**The Election for College Students Union and Central Councillor of DUSU 2024-25 will be held as per schedule hereunder:-**



5. **Bonafide voters are required to carry their College Identity card (duly renewed and mandatory for III and V Semester students) and fee slip (for semester I students ) with pasted photo duly verified by concerned course dealing Assistant and an additional Original Photo for Semester I Students Identity card proof (Pass Port/Aadhar Card/ Voter Card/ Pan Card/Driving License).**
