

**Note**

1. All the Candidates must follow the code of conduct for Election as notified by University of Delhi which becomes effective with this notification.
2. Candidates filled nomination /withdrawal already need not to submit again. Only either single fresh nomination or withdrawal can be filled through candidates registered email ID as per the admission form in the college records only.
3. Nomination papers for the Office bearers of College Students Council and Central Councillor can be downloaded from the college website **[www.dsc.du.ac.in](http://www.dsc.du.ac.in)**.
4. The duly filled prescribed nomination papers / withdrawal of nomination for office bearers of College Union and CC to returning officer through official email ID registered in college admission records to [principal@dsc.du.ac.in](mailto:principal@dsc.du.ac.in) on or before 12th September, 2025 till 11.59 pm only.
5. Documentary requirement remains the same (including copy of self attested passbook /cancelled cheque used in Surety /indemnity form ) in the form of a single clearly visible non-editable PDF file submitted through candidates registered email ID as per the admission form in college records only.
6. **Bonafide voters are required to carry their College Identity card (duly renewed and mandatory for III, V and VII Semester students) and fee slip (for semester I students ) with pasted photo duly verified by concerned course dealing Assistant and an additional Original Photo for Semester I Students Identity card proof (Pass Port/Aadhar Card/ Voter Card/ Pan Card/Driving License).**
